Check your State Pension now!



Currently, voluntary contributions can be made to fill gaps going back to April 2006, but as from 1 August 2023 this will be curtailed to go back only 6 years.

To check whether you are forecast to receive a full state pension and view your national insurance record **click here:**

If you have missing years and your gaps are in the years 2006 to 2017 then you need to take action to fill these by 5 April 2025.

You may be eligible to claim free credits, so check this first. The criteria and how to claim can be found here:
