What about the professional qualifications?

As a graduate you will most likely look to study towards one of the following qualifications:

ACA (ICAEW) - Institute of Chartered Accountants in England and Wales

For the ACA qualification you are required to complete at least 450 days of on-the-job training while passing up to 15 exams, depending on exemptions, across a range of topics such as financial management, law, ethics and professional development. Completing the ACA qualification enables you to use the title “Chartered Accountant”

ACCA - Association of Chartered Certified Accountants

For the ACCA qualification you are required to complete at least 3 years on-the-job training while passing up to 13 exams, depending on exemptions, across a range of topics such as audit and assurance, financial reporting and an ethics and professional skills module. Completing the ACCA qualification enables you to use the title “Chartered Certified Accountant”.

CTA (CIOT) - Chartered Institute of Taxation

The CIOT is the leading body for all aspects of taxation in the UK. Admission to membership of the CIOT requires success in the CTA exams, held every May and November, together with the ability to demonstrate 3 years’ relevant professional experience and enables you to use the title “Chartered Tax Adviser”.
